Summer Session 2023 Modality: Course Changes &

Informational Survey

Summer Session is asking for your help for planning purposes. On a daily basis, emails from students are asking if courses are going to be taught remotely. On February 2 (the deadline to submit courses to the Registrar), there are more than 100 courses submitted as remote instruction. Now that Summer Session has special approval for non-R courses to be offered as remote instruction, it would be helpful to know if academic departments are planning to submit scheduling updates to the Scheduling Office when The Look for Summer Session 2023 is released on March 15.

To make a change to courses listed on 'the Look' released from the Registrar on March 15, the department submits changes directly to Scheduling Office. If 'the Look' doesn't include courses the department wants to add, the first step is to add the courses to the ISA for approval from Summer Session, and then the second step is to submit the courses to the Registrar.

Modality changes can be submitted beginning March 15 and before student enrollment begins on April 17. The schedule of classes goes live on March 23.

Reminder: Courses are approved to move from in-person to remote without approval from Summer Session. If a change in modality from remote to inperson is requested after April 17, please contact Summer Session for special approval.

In the meantime, Summer Session is reviewing various types of programs proposed for summer 2023, and it would be helpful if you could submit an estimation of the approximate number of courses that your unit might submit to change from in-person to remote instruction. This survey is a best-guess because the summer schedule is a rapidly-changing environment. If you are responsible for more than one department's offerings, please complete the survey for each department that you manage.
