

## Summer 2022 Enrollment & Headcount Week 14

Enrollment – 33,437 – down 4% Headcount – 14,390– down 1% (Statistics compared with the same week last year.)

## Waitlist Enrollments Session 2 only – Current Week 1,181 vs. Previous Week 1,279

(Waitlist has concluded for Session 1 and Special Session. Students who remained on these waitlists were notified and provided with resources to contact their dept. & college for advising of other course options.)

# Summer Session 2 - instruction begins August 1, 2022

Saturday, July 23	Students will see financial aid disbursed to their TritonLink student accounts.			
Monday, July 25	Payment deadline for Session 2 tuition & fees. Waitlists are suspended.			
Friday, July 29	Students are canceled from Session 2 classes for nonpayment.			
Saturday, July 30	Automatic Waitlist process resumes.			
Monday, August 1	Instruction begins.			
Wednesday, August 3	Automatic Waitlist process ends.			
Friday, August 5	Last day to add a class via WebReg. Last day to drop a class with 100% tuition reversal/refund. There are no refunds for drops or withdrawals made after this date.

**Important Note**: We've changed the Mass Upload sheets. Now you only need to enter the job code, Empl Id, and Empl Rcd. **Please actually look-up the Empl Rcd number** - don't guess what you think it will be.

2. When complete, please add "DONE" to the file name and email <u>summer-payroll@ucsd.edu</u>.

#### For Graduate Students (Associate-Ins or TAs)

If you would like Graduate Division to process the additional pay for your Associate-Ins and TAs in a mass upload, you must download a blank spreadsheet, fill it in, and submit to Graduate Division via their Google Form.


