

Summer 2022 Enrollment & Headcount Week 15

Enrollment – 33,608 – down 7% Headcount – 14,515– down 5% (Statistics compared with the same week last year.)

Waitlist Enrollments Session 2 only – Current Week 995 vs. Previous Week 1,181

(Waitlist has concluded for Session 1 and Special Session. Students who remained on these waitlists were notified and provided with resources to contact their dept. & college for advising of other course options.)

Payment deadlines for session 2

Monday, July 25	Payment deadline for Session 2 tuition & fees. Waitlists are suspended.			
Friday, July 29	Students are canceled from Session 2 classes for nonpayment.			
Saturday, July 30	Automatic Waitlist process resumes.			
Monday, August 1	Instruction begins.			
Wednesday, August 3	Automatic Waitlist process ends.			
Friday, August 5	Last day to add a class via WebReg. Last day to drop a class with 100% tuition reversal/refund. There are no refunds for drops or withdrawals made after this date. Summer Session Administrative Drop Date students who owe more than \$500 and are in "EN" status will be administratively dropped.

You will not be able to see employee record information in Person Org Summary for instructors with appointments that have an effective date of 8/1/22. (aka future dated appointments)

The Triton Testing Center (TTC) has opened up to serve all departments and divisions this Summer Session 2022.


