New Request for Course Notes about Modality from Departments

Remote only:

If the faculty only wants to offer this course if remote modality is approved.

In-person only:

If the faculty only wants to teach in-person

Remote or in-person:

If the faculty is willing to teach a remote course, but will teach inperson if remote modality is not approved
