#### Summer 2025 Dates:

**Session 1:** June 30 - August 2, 2025

**Session 2:** August 4 - September 6, 2025

**Special Session:** June 16 - September 19, 2025

#### Summer Session 2025 timeline:

**October** - Academic departments & programs begin discussion of summer 2025 course offerings. The *call letter* will be coming out later this week.

**November** - Use the Instructional Scheduling Assistant (ISA) to propose summer course offerings.

**December** - Courses are approved and the preview of classes is posted to the website. Departments & programs will then be able to check the approved status in the ISA.

**January** - Academic departments & programs work with the Registrar-Scheduling team on the initial scheduling submission.

## **New Summer Session tuition rate:**

There will be no increases in the Undergraduate tuition for summer. For undergraduate students, the summer session per-unit rates UG rate remains the same at \$279 per unit.

The Graduate tuition rate will increase from \$374 (Summer 2024) to \$389 (Summer 2025).
