- a. Option 1 Deadline 7/1 Submit a spreadsheet to process payments using the Additional Pay Mass Upload with GEPA
- **b.** Option 2 Enter the Additional Pay manually in UCPath Follow <u>UCPath</u> processing deadlines.

- <u>Is every section (same course, several sections) of a course that is on the approved list paid \$500?</u>
 - Yes
- How often is the list updated?
 - Courses are selected from the previous academic year 2022-2023.
- Do courses on the approved high impact list (\$500 per course)
 also qualify for the departmental incentive program of course
 enrollment \$50 and \$1000 per course?
 - Yes, academic departments are allocated \$500 +
 \$1,000 per course and \$50 per enrollment.
