Students begin enrolling next month on Monday, April 14. Enrollment will be open through July 7 for Summer Session 1, and through August 8 for Summer Session 2.

Intentional Growth for Summer 2025

Here are some tips to help grow summer in order to meet student demands:

- Read the new <u>Summer 2025 Growth Guide</u> on our website for recommendations on how to grow your summer enrollment.
- Review the <u>High Impact Course list</u> to identify courses that will help students repeat a course.
- Consider increasing the total number of courses offered in 2025 by 3-5% over summer 2024 to meet student demand.
- Think about setting goals to achieve capacity initiative for courses by adding prior enrollment + prior waitlist.

Revised SB 791 Process for Summer Session Appointees

The SB 791 Compliance Process has been updated and simplified for Summer Session appointees. Review the updated slides on the Summer Session website.

Departments will need to:

- 1. Determine which of their visiting instructors need SB 791 clearance.
- 2. Request the misconduct questionnaire for those candidates on the APS website.
- 3. Final step is to include the clearance notification in the candidate's

Interfolio file.
