Summer Session 2026

Summer 2026 Dates:

Session 1: June 29- August 1, 2026

Session 2: August 3 - September 5, 2026

Special Session: June 15- September 18, 2026

October - academic departments & programs begin discussion of summer 2025 course offerings.

November - use the Instructional Scheduling Assistant (ISA) to propose summer course offerings.

December - Courses are approved and the preview of classes is posted to the website. Departments & programs will then be able to check the approved status in the ISA

January - academic departments & programs work with the Registrar-Scheduling team on the initial scheduling submission.

Priority Deadline: October 15, 2025 | Programs in need of Housing, Dining and Hospitality Services are strongly encouraged to submit their programs by

the priority deadline.

Deadline: November 12, 2025 | All submissions received after November 12 will be considered late, and support for Summer 2026 may be difficult, or in some cases not possible to provide.

Form Closure: Wednesday, January 7, 2026 | Late submissions will be accepted until Wednesday January 7, 2026. After this date, the inventory form will be made available by unique link to unaccounted programs as needed.
